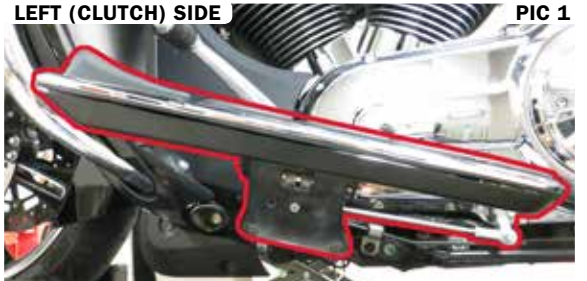

- STEP 1** Read and understand all steps in the instructions before starting the installation. Park the motorcycle on a hard, level surface and turn off the ignition. Let motorcycle cool.
- STEP 2** Refer to PIC 1 and 2. Disconnect and remove the shifter linkage. Set it and hardware aside until later.
- STEP 3** Refer to PIC 1 and 2. Disconnect floorboard mounting bracket and remove floorboard and shifter lever as a unit. Set hardware aside until later.
- STEP 4** Refer to PIC 3 and 4. Locate provided Heel Shifter Lever, two (2) M6 X 1.0 X 20MM Screws, and two (2) M6 Flat Washers. Place a washer on each screw.
- STEP 5** Refer to PIC 4. Align the bottom holes of the Heel Shifter Lever with the holes of the toe shifter lever. The Heel Shifter Lever should be placed on the inside, closest to the floorboard.

- STEP 6** Refer to PIC 5 and 6. With the washer placed on a 20MM screw, insert the assembly into the top holes on the back side of the aligned levers; loosely tighten. Adjust the Heel Shifter Lever's bottom hole to be seated towards the back of the oblong hole of the toe shifter. Insert the screw and washer assembly into bottom hole. Fully tighten both screws.

Note: It is important that the bottom hole of the Heel Shifter Lever is positioned correctly, otherwise you may encounter clearance issues between the floorboard and Heel Shifter Lever.

- STEP 7** Attach Shifter Peg (sold separately) to Heel Shifter Lever.

Note: Refer to PIC 7 and 8. If levers appear to be a little loose, locate provided .020 Spacer. Remove the large bolt connecting the levers to the mounting bracket. Be aware of additional washer and hardware that may come loose with the bolt. Place the spacer over the back side of the hole that the bolt was removed from. Reinstall the hardware and bolt. Fully tighten hardware.

- STEP 8** Refer to PIC 9. Locate the shifter linkage and hardware that was removed in Step 2. Reconnect the shifter to the bottom hole of the lever assembly. Be sure hardware is full secured.

- STEP 9** Refer to PIC 10. Loosen the two nuts and adjusters on each end of the shifter linkage.

Note: Each side is threaded differently. One is left thread and the other is right thread. This is important to know when you re-tighten them later.

- STEP 10** Refer to PIC 11. With the shifter linkage positioned above the mounting bracket, align and fasten the assembly to the bike using the bolts that were removed in Step 3. Fully tighten hardware.

- STEP 11** Reconnect the shifter linkage to the bike. Adjust the position of the heel and toe shifter levers up and down by twisting the shifter linkage bar. Once levers are in desired position, fully tighten the lock nuts on each end.

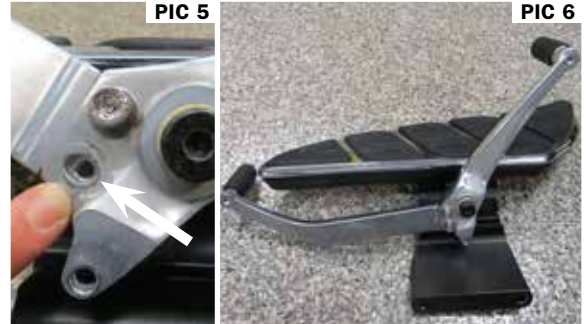
- STEP 12** Verify that you have clearance on all moving parts and that nothing is binding.
